Overview of Seminar Topics

Topic I - Latest information on IP system in each country

The speakers will introduce recent developments in laws, practices, court rulings, and/or national policy concerning intellectual property in China, Japan and Korea.

Topic II - Second medical use or indication claims

This topic will bring the audience the opportunity to learn about and compare the laws and practices in the three countries concerning the type, scope and enforcement of patent protection for new uses of known chemical compounds when a known substance is found to have a new therapeutic use.

This topic corresponds to AIPPI Working Question Q238.

Topic III - IP licensing and insolvency

In this session, the speakers will present on the law and practice concerning the treatment of IP license agreements during bankruptcy or insolvency proceedings. In particular, it will be discussed as to whether an administrator of bankruptcy or insolvency proceedings may adopt, modify, or terminate IP license agreements and liquidate IP rights underlying the license agreements.

This topic corresponds to AIPPI Working Question Q241.


KOFIC Namyangju Studios
